INFORMATION ON THE PROCESSING OF PERSONAL DATA

Dear Sir / Madam,

we wish to inform you, as data controllers, of art. 13 of the EU Regulation n. 2016/679 (so-called "GDPR" or European Regulation no. 2016/679), laying down provisions for the protection of persons and other subjects regarding the processing of personal data, we wish to inform you that the personal data you provide will be processed in compliance of the aforementioned legislation and the confidentiality obligations to which the Antonio Tabucchi Cultural Association is bound.

Holder of the treatment. The Data Controller is the Antonio Tabucchi Cultural Association, in the person of the President and legal representative pro tempore Riccardo Greco, domiciled for the office in Vecchiano (PI) at Via dei Magagna, 21.

Purpose of the processing. The treatment is directed: to the fulfillment of the institutional purpose of the Association (e.g. list of members, accounting, tax documents, etc.), to respond to any calls / regulations (e.g. calls for the third sector, communication of Bodies and Ministries etc.), for sending correspondence, summoning to meetings of the bodies, internal administrative procedures, for the institutional purpose of keeping the Register of Shareholders, for fulfilling legal obligations (e.g. tax, insurance, etc.) relating to members of the Association, for statistical analysis, also in aggregate form and in relation to images / videos, for publication on the Association's website, on the Association's social networks or on newsletters or on paper material to promote the institutional activities of the Association with your explicit consent.

Processing methods. The processing of data takes place both on paper and through the use of IT tools, according to the principles of correctness, lawfulness, transparency, relevance and not excess with respect to the purposes of collection and subsequent processing and after adopting the appropriate security measures aimed at to prevent the loss of data, illicit or incorrect use, unauthorized access and in general aimed at ensuring compliance with the provisions of the GDPR and Legislative Decree no. 101/2018 and subsequent amendments. The data is processed exclusively by administrative and technical personnel authorized to process it or by any authorized persons for occasional maintenance operations.

Communication and dissemination scope. We also inform you that the data collected will never be disclosed and will not be communicated without your explicit consent, except for the necessary communications that may involve the transfer of data to public bodies, consultants or other subjects for the fulfillment of legal obligations. .

Transfer of personal data. Your data will not be transferred either to member states of the European Union or to third countries outside the European Union.

Obligation or right to provide data. The user is free to provide personal data entered in the request formats. Failure to provide the data necessary to provide the service may make it impossible to obtain what is requested.

Retention period. Pursuant to art. 5 GDPR, the data will be processed and stored for a period of time not exceeding the achievement of the purposes of the service and processing and / or in compliance with the terms established by law or regulation.

Rights of the interested party. All the rights specified in art. 15 - 20 GDPR; these rights can be exercised by written communication to be sent by e-mail, p.e.c. or fax, or by registered mail at the headquarters of the Association.
